3. 25% of the shares subject to the option vested and became exercisable on the one year anniversary of January 27, 2012 (the "Vesting Commencement Date"), and 1/48th of the shares vest in equal monthly intallments thereafter, such that the option shall be fully vested and exercisable on the four year anniversary of the Vesting Commencement Date.

4. 25% of the shares subject to the option vested and became exercisable on the one year anniversary of June 26, 2013 (the "Vesting Commencement Date"), and 1/48th of the shares vest in equal monthly intallments thereafter, such that the option shall be fully vested and exercisable on the four year anniversary of the Vesting Commencement Date.

5. 25% of the shares subject to the option shall vest on the one year anniversary of January 29, 2014 (the "Vesting Commencement Date"), and 1/48th of the shares vest in equal monthly intallments thereafter, such that the option shall be fully vested and exercisable on the four year anniversary of the Vesting Commencement Date.
